RE: AB 14 (Aguiar-Curry): Internet for All Act of 2021 – SUPPORT

Dear Assemblymember Santiago:

The California Telehealth Policy Coalition is proud to support AB 14, the Internet for All Act of 2021 (The Act), which prioritizes the deployment of broadband infrastructure in California's most vulnerable and underserved communities, by extending the ongoing collection of funds deposited into the California Advanced Services Fund (CASF) to provide communities with grants necessary to bridge the digital divide.

As a group of over 100 diverse organizations dedicated to advancing telehealth policy in California, we recognize the key role that broadband and internet access play in connecting Californians to the care they need, especially during the pandemic where telehealth has played a critical part in keeping Californians safe and healthy.

AB 14 recognizes that reliable internet connectivity is a basic necessity now, and that this will remain the case even after the COVID-19 pandemic has subsided. The Public Policy Institute of California reports that only 59% of rural households in California have access to broadband speeds of at least 25mbps/2mbps.¹ This means that over 40% of rural Californians often lack access to broadband speeds that can provide the minimal bandwidth required to stream live video telehealth visits, visits which are often conducted while other household members are using the internet for education and work purposes.

In light of these issues, the Coalition adopted and supports the following principles:

- **Broadband should be treated as a utility:** policies must treat broadband as a utility necessary for Californians to access health care and other services and needs in the 21st century
- **Robust infrastructure should be in place to serve all Californians:** policies must expand the physical infrastructure needed to bring internet access to underserved populations and geographies
- **Californians should have equitable access to broadband:** policies must ensure increased access to broadband for underserved communities, both urban and rural
- **Broadband should be affordable:** policies should support making high-quality internet access affordable for all Californians, including the use of subsidies and/or affordable price setting
- **Government should fund broadband projects that rely on best-in-class, high-speed standards:** policies should ensure that infrastructure, accessibility and affordability reinforce the need for high-speed, best in class technologies

Telehealth has been shown to reduce existing health inequities, and according to the CDC, the ongoing COVID-19 pandemic has only increased barriers to healthcare for the underserved, including racial and ethnic minority groups. Meanwhile, the potential to reach those communities through telehealth is hindered by the fact that it is these most vulnerable Californians who remain disproportionately disconnected from broadband. AB 14 is a critical step towards expediting the deployment of broadband infrastructure throughout the state and providing a vital pathway to connect Californian's to necessary health care, as well as a number of other important services.

For these reasons, we are pleased to support AB 14 and respectfully request your eye vote on this essential legislation.
